- Awarded 2017-18 VA Alcoholic Beverage Control (ABC) Authority Education & Prevention Grant of \$10,000.00
- Completed year two of White House's Office of National Drug Control Policy Drug-Free Communities (DFC) Grant, which awards \$125,000.00 annually for five-years
 - Hanover Community Services Board, Hanover County Sheriff's Office, Ashland Police Department and other community stakeholders and prevention partners provide the required federal match for the DFC grant, with in-kind support equaling \$125,000.00 annually
- Hosted Spirit Night Fundraisers at Riverbound Café (\$255.00) and Marty's Grill (\$500.00)
- Grace Haven Management was a sponsor for Hidden in Plain Sight event, with a \$100 donation
